GCSE Dance NEA – Performance and choreography (8236/C)(version 2.0)

Guidance notes for teachers on completing the candidate record form

Performance assessment

Set Phrase

If a student's performance does not contain an attempt to reproduce **one** set phrase it will not be accepted as assessment evidence and the candidate will be **awarded zero**.

On the candidate record form you will provide the following:

- The name of the set phrase used for this assessment
- A single mark out of 4 for demonstration of physical skills and attributes safely to reproduce the set phrase
- A single mark out of 4 for demonstration of technical skills and attributes safely to reproduce the set phrase
- A single mark out of 4 for demonstration of expressive skills to reproduce the set phrase
- A total mark out of 12

At the end of the performance section of the CRF there is a comments box in which you should add supporting notes in terms of the marks awarded.

Note: When viewing the phrase you are advised to write notes which reference how well and in what ways the candidate met the assessment criteria and to use these in forming a judgement.

Solo/Duet/Trio

On the candidate record form you will provide the following:

- The names of the two set phrases used in the creation of the piece performed
- A single mark out of 8 for demonstration of physical skills and attributes safely to reflect choreographic intent
- A single mark out of 8 for demonstration of technical skills (excluding relationship content for a solo) and attributes safely to reflect choreographic intent
- A single mark out of 8 for demonstration of expressive skills (excluding sensitivity to other dancers for a solo) to reflect choreographic intent
- A total mark out of 24

The comments box at the end of the performance section should be used to detail any supporting notes to explain the marks awarded.

Teachers must provide a programme note in accordance with the instructions in the specification (3.1.2.1). Where the programme note is identical for all candidates in the centre, only one should be provided. Where candidates have different programme notes a copy of the relevant notes should be attached to each candidate record form.

Mental Skills

In order to access the marks available for mental skills in performance the candidate must provide credible evidence for both the set phrase and solo/duet/trio performances (specification 4.2.1.1)

On the candidate record form you will provide the following

- A single mark out of 4 for mental skills and attributes covering **both** performances – the set phrase and the solo/duet/trio

Please use the comments box to explain the marks awarded especially if there is an imbalance of ability shown in the two performances.

Note: When viewing each performance you are advised to write notes which reference how well and in what ways the candidate met the assessment criteria and to use these in forming a judgement in order to give the overall mark.

Performance Total

On the candidate record form you will provide the following

- A total mark out of 40 for the performance assessment (set phrase + solo/duet/trio + mental skills)

Choreography assessment

On the candidate record form you will provide the following:

- A single mark out of 8 for selection and use of appropriate action content and dynamic content to realise choreographic intent
- A single mark out of 8 for selection and use of appropriate spatial content (and relationship content where appropriate) to realise choreographic intent
- A single mark out of 8 for selection and use of appropriate structuring devices to realise choreographic intent
- A single mark out of 8 for selection and use of appropriate choreographic devices to realise choreographic intent
- A single mark out of 8 for selection and use of appropriate aural setting (and performance environment where appropriate) to realise choreographic intent
- A total mark out of 40 for the choreography assessment

The comments box at the end of the choreography section of the CRF should be used to detail any supporting notes to explain the marks awarded.

Overall total for the NEA component (8236/C)

On the candidate record form you will provide the following:

- A total mark out of 80 (performance total + choreography total)
