

#### Case study: Willow Dene School

Mark Clayton works at Willow Dene School in Croydon and has told us how they use UAS within their centre.

We are a large special school based in Greenwich with a recently opened secondary provision. Last year we had our first cohort of Key Stage 4 learners. In preparation for this, we were keen to establish a route to accreditation that was meaningful and provided a personal recognition of achievement for our learners. After lots of research we decided that the Unit Award Scheme gave us the freedom to create bespoke, appropriate pathways of learning that are tailored to the needs of our children.



We have used the Unit Award Scheme for approximately two years: first running a pilot scheme and then evolving this as the recognised accreditation route for our Key Stage 4 curriculum. Initially we used units from the Unit Award Scheme's existing bank of units and, if necessary, made some minor amendments. As this year has progressed, we have moved towards creating bespoke Unit Award modules for our learners which are finely attuned to their interests, strengths and required skills for their future career paths and education. To help us create these bespoke units, we use knowledge of our children gained through our Key Stage 3 curriculum and our annual Specialist Interest Afternoons where we celebrate each child's personal interests, passions and strengths. In the past, these have included DJ sessions, eye gaze art and photography, amongst many others.

Our use of the Unit Award Scheme is intrinsically linked to our careers strategy which aims to prepare students for their next steps, which may include working and independent living. An example of this is one child's work towards a unit based on the skills required for public speaking. We created and facilitated a meeting with a local employment officer and disability campaigner who has similar medical needs to the student studying the unit. The meeting was powerful and impacted positively, providing inspiration for our learner. The result was a learner who succeeded in gaining the planned UAS skills but, in addition, created a meaningful contacts network in order to assist them in gaining future employment and support.

All of our children will leave the school at the end of Key Stage 4 with real clarity about the direction of their onward journey and a Record of Achievement which gives a personalised overview of their accreditation route so far. The Unit Award Scheme allows our children to demonstrate their certificated skills that are pertinent and meaningful for their future through their portfolio.

### Unit submission checklist

We have created a brand new unit submission checklist. It is designed to allow you to check new or amended units against the main unit writing criteria before you submit them for validation. You can find the new checklist in the documents section in Gateway.

The checklist replaces the unit writing feedback form that any of you who submitted units last academic year will have received along with your newly validated units.

Please remember not to reformat your claim form, add or delete rows or columns, use filters, add worksheets or include learners who have not achieved units.

Always check that the summary sheet: has the correct unit code and title, is signed by both the unit teacher and the coordinator (including any additional pages), matches the claim form, has a completion date on the final sheet and has dates (not ticks) for the outcomes.

We look forward to receiving your claims and assessments and working with you to deliver another successful year, for you and your learners.


